Public Works Report

A Hydrant was leaking near Golf Course by Tim Hansen's residence. Public Works was able to repair the hydrant without having to dig it up. There's been brush to pick up after the storms. Public Works cleared out brush near the burned rail road bridge for the contractors to have an easier access to it when they begin work on it.
