Erik Stinson-DPW reported that he and Dennis Looker attended the annual Rural Water Conference. Both earned 15 credits for water certification. A Knight/Jaffke motion and subsequent vote approved the Public Works Training Report.

CDC Report

CDC Tim Swiggum reported the application for the T-Grant is almost ready for submission, for the Heartland Development Project. Also, the DNR will fund the Phase 1 study. Once completed, the City can move forward in obtaining the VPLE Insurance. A meeting was held with the interested party in the Agri-Business Park/Commercial Park along with representatives from USDA Rural Dev., UWEC, CCEDC, Erik Stinson-DPW, Wisconsin Economic Development Corp., and Wisconsin Central Wisconsin Regional Planning. The project is planned for 2018. The City will need to look into street costs. The DRC met and is planning an ATV pull at their Autumn Fest in October. Parks & Rec. met. Erik-DPW is looking into streets, water and sewer in the Country Side Estates. A Wilczek/Wagner motion and subsequent vote approved the CDC report.

Clerk Ernst presented Pay Request #3 to August Winters for the Lift Station #1 project for \$502,930.00. A Mauel/Knight motion and subsequent vote approved Pay Request #3.

Easements

The following three easements were presented for the Lift Station #1 project. 1) A Mauel/Knight motion and subsequent vote approved the conversion of storm easement and water easement into utility easement over parcels owned by Town & Country. 2) A Mauel/Milliren motion and subsequent vote approved the conversion of Town & Country confinement of Easement. 3) A Wilczek/Wagner motion and subsequent vote approved to grant easement to WE Energies over City property to Lift Station #1.

Personnel Committee Report

Pam Jaffke-Chairman reported the committee met on April 3rd. A 3 month review was completed for Officer Dulcie Lilly with a wage change from \$20.25 to \$20.75. A Wilczek/Milliren motion and subsequent vote approved the pay increase to Officer Lilly. The committee also discussed possibly amending the residency requirement. Other municipalities were discussed who have dissolved the requirement altogether. A Milliren/Mauel motion and subsequent vote approved to table the issue until the next Council meeting.

Parks & Rec. Report

Their next meeting will be held 4/19/17 at 6 pm. A Mauel/Jaffke motion and subsequent vote approved the budget increase to \$10,000.
